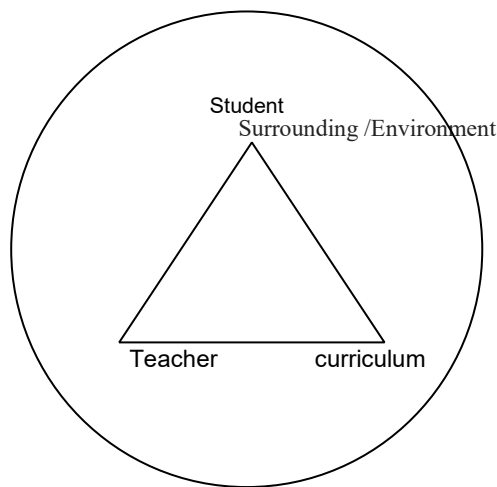

In the constructivist theories the learner builds the knowledge internally affected by the surrounding environment, the society, and language. Every learner has his own special way of learning in understanding knowledge. So, the preoccupation of the teacher in sending the knowledge to the learner and the confirmation and replication are not useful in building the information as he wants in the way he gained popularity in recent mind of the learner. The roots of this constructivist theory have been around for many years. This idea is not modern. Trends toward constructionist theory can be seen in the works of ancient philosophers (470-BC), all of whom spoke about "knowledge is not put into you, you have to rely on sensory experiences when formation". St. Augustine (mid 300 BC) says, "You cannot see the truth, people look for the truth"

Although the main philosophy of construction is attributed to Jean Piaget (1896-1980), who produced similar results more than a century ago, he stressed the need for more appropriate educational methods on the natural development of the child and his thoughts and to adapt to the child's feelings, which he stressed the importance of the senses as tools for learning, and advocated linking educational curricula with children's experiences in their lives at home and family environments. It is not strange to see that this constructivist theory has historical roots across the centuries. It is also not a strange that several philosophers and theorists give this theory a huge attention during decades while the only modern theorists have tried to install theory in an integrated and comprehensive theory. Make of the foundations of the modern base of growth psychology is from Jean Piaget, who unified the philosophy and psychology on the thinking and intelligence of children, and he opened the psychology to focus attention on the way to a new perspective and a new organization in education and psychology

Constructivism is derived from the construction of a building and it derived from the Latin word *construere*, meaning the way a building is constructed. So, education it can be origin of the building defined as a "vision or theory of learning and child development, the child is active in building his own life-his thinking patterns from the interaction of his abilities with real world. The structure is expressed in its simplest form and its meanings are explained by the fact that knowledge is actively adopted by the learner and does not receive it negatively from the environment Learning principles of the structural theory has several concerns and aspects.

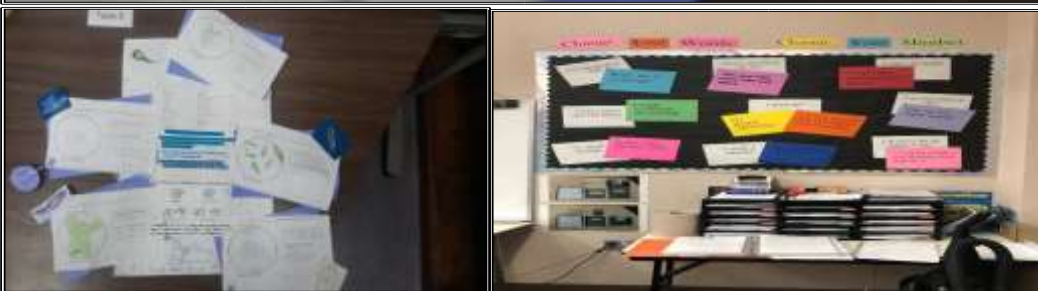
